## 2nd Annual LEAP Banquet A Success



The 2nd annual LEAP banquet was held on Wednesday, September 26 at the Down Under Ballroom with Marci Penner, founder of the Kansas Sampler Foundation, as the keynote speaker.

Over 120 Leadership Mitchell County alum and residents attended the event.

Katie Cheney, class X, welcomed everyone to the event. Mandy Fincham, class X, introduced Penner as the banquet's speaker.

Penner formed the Kansas Sampler Foundation with her father in 1993. Through the foundation, the yearly Kansas Sampler Festival evolved, the Kansas Guidebook for Explorers

was written and the 8 Wonders of Kansas contest was formed.

Penner spoke about rural Kansas: It is what we make it. In the 2000's, she traveled to each of the 626 incorporated cities and came up with many ideas and met wonderful people who make things happen in small communities. "We need enthusiasm to do the work we do in rural communities," said Penner to open her speech.

Penner had four major points to help make rural communities thrive. The first was finding Good Thinkers. These are people who listen and ask questions. They see a seed of an idea and they go with it.

The second point is innovative thinking. She gave the example of the small town of Muscotah. Their water tower had to come down, which was a ball on a pedestal. Because Joe Tinker, a major league baseball player for the Chicago Cubs and Cincinnati Reds in the 1940's grew up in Muscotah, they decided to make the ball portion of the water tower a baseball museum.

Her third point was the 8-98 Plan. How do we get everyone from the age of 8 to 98 involved in our community? Penner suggested everyone fill out a talent assessment and community members can trade talent for talent.

And her final point is the PowerUp Movement. PowerUps are those between the ages of 21 and 39 who live in a rural area by choice. PowerUps are of value to small communities because they are the future and who will keep them our communities alive. "We need to ask their advice and ideas, not just do things the same way we've always been doing them," suggested Penner. More importantly, she urged PowerUps and PowerOns, those over 40 who choose to live rural, to work together to get things done. "Together, we can do it!," stated Penner.

After Penner's speech, Cheney and Fincham handed out door prizes. Class XII won the best decorated table contest, which was decorated in an Amelia Earhart and aviation theme. ♦

## Mitchell County Candidate Forum

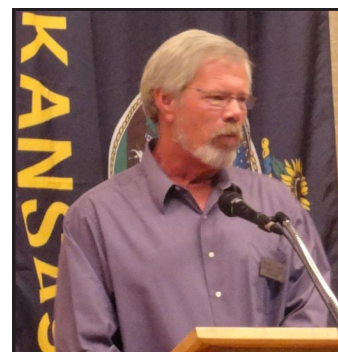
